RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, PhyServe has granted to the Secured Party a security interest in (i) all of its trademarks and trademark applications, including but not limited to the Listed Trademarks and (ii) associated business goodwill therein, all as described in that certain Trademark Security Agreement dated as of September 1, 2009 executed by PhyServe (the "PhyServe Trademark Agreement", and together with the MedEdge Trademark Agreement, collectively, the "Trademark Agreement").

WHEREAS, the Secured Party has at the Company's request agreed to release its security interest in all of the Company's trademarks, including the Listed Trademarks, and the registrations thereof and the associated business goodwill therein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases its security interest in all of the Company's trademarks and trademark applications, including the Listed Trademarks, and the registrations thereof and the associated business goodwill therein and to any other rights it might have arising out of the Trademark Agreement.
