## RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is dated as of December 17, 2010, by Maranon Capital, L.P., a Delaware limited partnership, in its capacity as agent for certain lenders ("Agent") under that certain Second Lien Credit Agreement dated as of August 17, 2009 by and among PKWARE, Inc., P2009 Acquisition Co., PKW Holdings, Inc., certain other parties thereto from time to time, Agent, and other financial institutions party thereto ("Credit Agreement").

WHEREAS, Agent and PKWARE, Inc., a Wisconsin corporation ("Grantor"), entered into that certain Trademark Security Agreement, dated as of August 17, 2009 (the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement granted Agent a security interest in, among other things, certain trademarks, trademark applications, and trademark licenses ("Trademarks"), including, without limitation, the Trademarks listed on Schedule I attached hereto as security for certain obligations of Grantor to Agent and certain other parties (the "Obligations");

WHEREAS, Agent recorded the Trademark Security Agreement on August 19, 2009, at Reel/Frame 004048/0688 in the United States Patent and Trademark Office; and

WHEREAS, Grantor has satisfied all of the Obligations and has requested that Agent release its security interests in the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

Agent hereby fully releases and terminates its security interests in and liens on all of Grantor's now existing or hereafter acquired right, title and interest in, to, and under the following, whether presently existing or hereafter created or acquired:

- (a) all of its Trademarks (as defined in the Credit Agreement) and Trademark Licenses (as defined in the Credit Agreement) to which it is a party, including those referred to on Schedule I hereto;
- (b) all reissues, continuations or extensions of the foregoing; and
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- (d) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.
