**Correction of Recordation of Security Interest**

This Release of Security Interest, effective the date of execution set forth below, by Bank of America Corporation, a financial holding company organized under the laws of North Carolina (hereinafter "Bank of America").

**PREAMBLE**

WHEREAS, International Typeface Corporation, a corporation organized under the laws of New York with a principal place of business at 500 Unicorn Park Drive, Woburn, Massachusetts 01801-3345, is the owner of United States trademark registration number 1,709,764 (serial number 74/113,313) for the mark "ITC" in international classes 9 and 16, (hereinafter "the ITC Mark") and has been the owner of the ITC Mark at least since the application filing date of November 7, 1990.

WHEREAS, BankBoston, N.A. ("BankBoston") recorded a Trademark Collateral Security and Pledge Agreement with Nielsen & Bainbridge (hereinafter the "Security Agreement" with the United States Patent and Trademark Office, to wit, USPTO document numbers 100,958,346; 101,195,446; and 900,019,003 (at Reel 001899, Frames 0647-0663; Reel 001968, Frames 0612-0640; and Reel 003021, Frames 0367-0368, respectively) (hereinafter "the Security Interests");

WHEREAS, BankBoston included the ITC Mark in the Security Agreement in error in that Nielsen & Bainbridge is not, and has never been, the owner, or owner of record, of the ITC Mark;

WHEREAS, by various and mesne conveyances, Bank of America Corporation, a financial holding company organized under the laws of North Carolina, with a principal place of business in Charlotte, North Carolina, is currently the successor in interest to Bank Boston, N.A. (hereinafter "Bank of America");

WHEREAS, Bank of America now wishes to correct the prior recordations as of the recordation dates and release and discharge any and all claims in or to the ITC Mark it may have acquired due to the error in the Security Agreement;

NOW, THEREFORE, in consideration of the amount of ten dollars in hand paid, and other good and valuable consideration, Bank of America states as follows:

1. The above Preamble is hereby incorporated as if fully restated in this Paragraph 1, and by this reference is made an operative part of this Correction of Recordation of Security Interest

2. Bank of America confirms that Bank of America, and its predecessors in interest, did not intend to take a security interest in the ITC Mark and hereby submits a corrected appendix to the Security Agreement, effective as of the original recordation dates.

3. Bank of America hereby remises, releases, and forever discharges the Security Interests and all right, title and interest in the ITC Mark that may have been created by or is relating to the Security Interests. Further, Bank of America hereby irrevocably disclaims any and all right, title or interest in or to the ITC Mark.
