AMENDED AND RESTATED GRANT OF
SECURITY INTEREST IN TRADEMARKS

THIS AMENDED AND RESTATED GRANT OF SECURITY INTEREST IN TRADEMARKS ("Agreement"), effective as of December 21, 2010, is made by NATURAL SELECTION FOODS, LLC, a California limited liability company (the "Grantor"), in favor of ROYAL BANK OF CANADA, as Administrative Agent (the "Agent") for the Secured Parties (as defined in the Guarantee and Collateral Agreement described below).

W I T N E S S E T H

WHEREAS, pursuant to the Credit Agreement, dated as of July 20, 2009, as amended and restated as of December 21, 2010, among Earthbound Holdings II, LLC, Earthbound Holdings III, LLC (the "Borrower"), the Administrative Agent and the banks and other financial institutions or entities from time to time parties thereto (the "Lenders"), (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, the Grantor has executed and delivered a Amended and Restated Guarantee and Collateral Agreement, dated as of December 21, 2010 in favor of the Agent for the ratable benefit of the Secured Parties (as amended, restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), which amends and restates the Guarantee and Collateral Agreement, dated as of July 20, 2009 (the "Existing Guarantee and Collateral Agreement");

WHEREAS, pursuant to the Existing Guarantee and Collateral Agreement, the Grantor entered into a Grant of Security Interest in Trademarks agreement, dated as of July 20, 2009 (the "Existing Trademark Agreement") in favor of the Agent for the ratable benefit of the Secured Parties, and the Existing Trademark Agreement was recorded at the United States Patent and Trademark Office on August 6, 2009 at Reel/Frame 4039/0560;

WHEREAS, pursuant to the Amended and Restated Guarantee and Collateral Agreement, the Grantor has pledged and granted to the Agent for the ratable benefit of the Secured Parties a continuing security interest in its Intellectual Property included in the Collateral, including the Trademarks included in the Collateral; and

WHEREAS, the Grantor has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make Loans and other financial accommodations to the Borrower pursuant to the Credit Agreement, the Grantor agrees, for the benefit of the Agent and the Lenders, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Guarantee and Collateral Agreement.

SECTION 2. Grant of Security Interest. The Grantor hereby pledges and grants a continuing security interest in the Trademarks included in the Collateral (including, without limitation, those items listed on Schedule A hereto), to the Agent for the ratable benefit of the Secured Parties to secure the Obligations.


SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Lenders in connection with the Guarantee and Collateral Agreement and is expressly subject to the terms and conditions thereof. The Guarantee and Collateral Agreement (and all rights and remedies of the Lenders thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Lenders with respect to the security interest in the Trademarks granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

IN WITNESS WHEREOF, the parties hereto have caused this Grant of Security Interest in Trademarks to be duly executed and delivered by their respective officers thereunto duly authorized as of the day and year first above written.
