- 1.2 The Assignor shall, at the expense of the Assignee or its assigns, execute and do all such documents and things as may be necessary or proper for legally vesting in the Assignee or its assigns the full benefit of the said Trade Marks.
- 1.3 Each party shall pay their own costs for professional services incidental to this Deed.

- 2.1 The Assignee acknowledges that it enters into this Deed for itself and for its successors and permitted assigns and for good consideration.

3. APPLICABLE LAW

- 3.1 This Deed shall be governed by and construed in accordance with the law of the State of New South Wales.
