CONTRIBUTION AGREEMENT

THIS AGREEMENT (this "Agreement") is dated as of December 23, 2010 by and between Ellery Homestyles Holding Corporation, a Delaware corporation ("Ellery Corp"), and Ellery Holdings LLC, a Delaware limited liability company ("Ellery LLC").

WITNESSETH:

WHEREAS, Ellery Corp has entered into that certain Asset Acquisition Agreement dated as of December 23, 2010, by and among Ellery Corp, Ellery Homestyles, LLC, a New York limited Liability company ("Ellery"), and EHS Far East Limited, a Hong Kong corporation ("EHS" and together with Ellery, the "Sellers"), pursuant to which, among other things, Ellery Corp will purchase substantially all of the assets of the Sellers, together with all the goodwill associated therewith, and assume ordinary trade and other ordinary course liabilities of Sellers, in exchange for cash and 50,000 shares of Class A Voting Common Stock of Ellery Corp (the "Asset Acquisition Agreement");

WHEREAS, upon the consummation of the transactions contemplated under the Asset Acquisition Agreement, Ellery Corp desires to contribute to the capital of Ellery LLC all of the Transferred Assets (as such term is defined in the Asset Acquisition Agreement) and Ellery LLC desires to assume all of the Assumed Liabilities (as such term is defined in the Asset Acquisition Agreement); and

NOW, THEREFORE, in consideration of the premises contained herein, and intending to be legally bound hereby, the parties hereto agree as follows:

1. Contribution of Assets. Ellery Corp hereby sells, assigns, transfers and delivers to Ellery LLC the Transferred Assets, including the intellectual property listed on Exhibit A hereto, as a contribution to the capital of Ellery LLC and Ellery LLC hereby assumes all of the Assumed Liabilities. Upon request of a party, each other party shall execute and deliver all documents and instruments from time to time necessary or desirable to evidence the transfer of the Transferred Assets and assumption of the Assumed Liabilities hereunder.

2. Assignment. This Agreement is not assignable by either party without the written consent of the other.

3. Binding Effect. This Agreement shall be binding on and inure to the benefit of the parties and their permitted successors and assigns.


4. Governing Law. This Agreement shall be governed by the laws of the State of New York.

5. Further Assurances. Each party agrees to execute such other documents and take such other actions as may be necessary to carry out the intention of the parties with respect to the subject matter hereof.


Complete Agreement. This Agreement represents the complete agreement of the parties and supersedes all prior agreements, understandings and discussions of the parties.
