**RELEASE OF
GRANT OF SECURITY INTEREST
TRADEMARKS**

WHEREAS, Accelerated Rehabilitation Centers, Ltd. NOW, THEREFORE, Agent does hereby authorize Pledgor, or its agents, to file release with the United States Patent and Trademark Office terminating the trademarks and service marks listed on Schedule A attached hereto.
