ASSIGNMENT OF TRADEMARK

A copy, photographic, facsimile or electronic, hereof together with original, photocopy, facsimile or electronic signature pages containing the original, photocopy, facsimile or electronic signature of Assignor, in any combination, shall constitute an original hereof.

This Assignment of Trademark is made pursuant to (and does not modify) the Agreement, which contains certain representations, warranties and covenants regarding the Mark. Capitalized terms used herein and not otherwise defined shall have the respective meanings set forth in the Agreement.


