TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of December 29, 2010, is entered into by and between SIGMA ELECTRIC MANUFACTURING CORPORATION, a Delaware corporation (the "Grantor"), having its chief executive office at 120 Sigma Drive Garner, NC 27529 and RBC BANK (USA), a North Carolina banking corporation, as Administrative Agent (the "Administrative Agent"), with offices at 11011 Richmond Avenue, Suite 850, Houston, Texas 77042, for the ratable benefit of the Secured Parties.

This Agreement is executed pursuant to the terms of (a) the Credit Agreement, dated of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among GSCP Sigma (Lux) S.à r.l., a private limited liability company organized under the laws of Luxembourg, GSCP Sigma (Lux) II S.à r.l. ("Lux II"), a private limited liability company organized under the laws of Luxembourg, GSCP Sigma Holding Corp. ("US Holdings"), a Delaware corporation, the Grantor, the Lenders who are or may become party thereto and the Administrative Agent and (b) the Collateral Agreement, dated of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), executed by Lux II, US Holdings and the Grantor in favor of the Administrative Agent, for the ratable benefit of the Secured Parties. Capitalized terms used herein but not defined herein shall have the meanings assigned to them in the Credit Agreement or the Collateral Agreement, as applicable.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor hereby confirms the grant pursuant to the Collateral Agreement, to the Administrative Agent, for the ratable benefit of the Secured Parties, of a security interest in all of the Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) each Trademark of the Grantor registered, and each pending Trademark application for registration, with the United States Patent & Trademark Office, all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including, without limitation, each such Trademark, described on Schedule A;
- (ii) all claims by the Grantor against third parties for (a) past, present or future infringement or dilution of any Trademark, including, without limitation, any Trademark described on Schedule A or (b) injury to the goodwill associated with any Trademark; and
- (iii) all products and proceeds of the foregoing.

The rights and remedies of the Administrative Agent, on behalf of the Secured Parties, with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall govern.


This Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed signature page of this Agreement by facsimile transmission or email transmission (including .pdf delivery) shall be effective as delivery of a manually executed counterparty hereof.

THIS AGREEMENT SHALL BE GOVERNED BY, CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO THE CONFLICTS OR CHOICE OF LAW PRINCIPLES THEREOF.


