TRADEMARK ASSIGNMENT

This Trademark Assignment is made effective December 31, 2010 by **Yuromgt, Inc.**, a Delaware corporation, having its sole place of business at 1201 N. Orange Street, Suite 724, Wilmington, Delaware 19801 (or "Yuromgt"), in favor of **Yuasa Battery, Inc.**, a Delaware corporation, having its principal place of business at 2901 Montrose Avenue, Laureldale, Pennsylvania 19605 (or "YBI").

WHEREAS: Yuromgt owns and (through a related party license agreement) has used and is using in the United States the trademarks, service marks or trade names identified on Schedule A to this Trademark Assignment (hereinafter referred to in the aggregate as the "Trademarks") which are registered in the United States Patent and Trademark Office to the extent noted on Schedule A.

WHEREAS: Yuromgt and YBI have entered into a **Plan of Merger and Complete Liquidation** pursuant to which Yuromgt will be merged with and into YBI, and all of the assets and liabilities of Yuromgt, including the Trademarks, shall be assigned to YBI, and the separate corporate existence of Yuromgt shall cease (hereinafter, the "Merger").

AND WHEREAS: it is desired that the assignment of said Trademarks contemplated by the **Plan of Merger and Complete Liquidation** be made of record in the United States Patent and Trademark Office.

NOW, THEREFORE, pursuant to the **Plan of Merger and Complete Liquidation**, and for good and valuable consideration the receipt of which is hereby acknowledged, Yuromgt does hereby assign and transfer unto said YBI, and for YBI's successors and assigns, all right, title and interest in and to each of said Trademarks, together with the goodwill of the business symbolized by said Trademarks, and the registrations thereof; and for aforesaid considerations Yuromgt hereby covenants, agrees and undertakes to execute whenever requested by YBI, all applications, assignments, lawful oaths and any other papers that YBI may reasonably deem necessary or desirable for securing to YBI, or for maintaining for YBI, all the Trademarks hereby assigned or agreed to be assigned; all without further compensation to Yuromgt.

IN WITNESS WHEREOF, Yuromgt has caused this Assignment to be executed by a duly authorized officer.
