IN UNITED STATES TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, COST PLUS MANAGEMENT SERVICES, INC., a California corporation (the "Grantor") with principal offices at 200 Fourth Street, Oakland, California 94607, hereby grants to BANK OF AMERICA, N.A., as Collateral Agent, with offices at 100 Federal Street, 9th Floor, Boston, Massachusetts 02110 (the "Grantee"), a continuing security interest in (i) all of the Grantor's right, title and interest in, to and under to the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications, and service mark applications (the foregoing, collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds (as such term is defined in the UCC (as defined in the Security Agreement referred to below)) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Grant") is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantor, as such term is defined in (i) the Intellectual Property Security Agreement among the Grantor, the other Grantors from time to time party thereto and the Grantee, dated as of June 25, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), and (ii) the Security Agreement among the Grantor, the other Grantors from time to time party thereto and the Grantee, dated as of June 25, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

This Grant has been granted in conjunction with the security interest granted to the Grantee under the IP Security Agreement and the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the IP Security Agreement and the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the IP Security Agreement or the Security Agreement, the provisions of the IP Security Agreement and the Security Agreement shall govern.

THIS GRANT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
