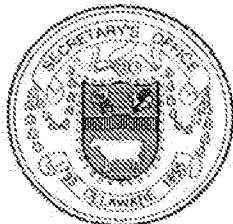

Pursuant to Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned limited liability companies,

DOES HEREBY CERTIFY AS FOLLOWS:

FIRST: That the name and state of formation of each constituent limited liability company of the merger is as follows:

SECOND: an agreement of merger ("Agreement of Merger") between the parties to the merger has been approved, adopted, certified, executed and acknowledged by each of the constituent limited liability companies in accordance with the requirements of Section 18-209 of the Delaware Limited Liability Company Act, in the case of Wilkinson Industries, LLC and Dispoz-o Products, LLC, and in accordance with the requirements of the Beverly-Killea Limited Liability Company Act of California, in the case of C&M Fine Pack LLC.

THIRD: upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware, C&M Fine Pack, LLC and Wilkinson Industries, LLC will each merge with and into Dispoz-o Products, LLC, and Dispoz-o Products, LLC will be the surviving limited liability company (the "Surviving LLC") and will continue its existence under the name "D&W Fine Pack LLC".
