## TRADEMARK SECURITY RELEASE AGREEMENT

TRADEMARK SECURITY RELEASE AGREEMENT, dated December 17, 2010 ("Trademark Security Release"), by UBS AG., STAMFORD BRANCH, a United States branch of a Swiss bank located at 677 Washington Boulevard, Stamford, CT 06901, USA, in its capacity as collateral agent under the Credit Agreement (in such capacity, the "Assignor"), in favor of NOVELIS BRAND LLC, a Delaware limited liability company, located at 191 Evans Avenue, Toronto, Ontario, M8Z 1J5, Canada (in such capacity, the "Assignee").

### W I T N E S S E T H:

WHEREAS, Assignee is party to a Security Agreement dated as of July 6, 2007 (the "Security Agreement") in favor of the Assignor, pursuant to which Assignee executed and delivered that certain Trademark Security Agreement, dated as of October 1, 2008 (the "Trademark Security Agreement") in order to record the lien and security interest of Assignor in the Pledged Trademark Collateral (as defined in the Trademark Security Agreement) in the United States Patent and Trademark Office (the "PTO");

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the PTO on July 2, 2009 at Reel 4016/Frame 0620;

WHEREAS, the secured obligations have been paid and performed in full and any and all other conditions for termination of the Trademark Security Agreement have been satisfied; and

WHEREAS, Assignor now desires to release its security interest in and to Assignee's right, title and interest in and to the Pledged Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein but not otherwise defined herein that are defined in the Trademark Security Agreement shall have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Release of Security Interest in Pledged Trademark Collateral. Assignor hereby terminates and releases in its entirety its lien on and security interest in all of the Pledged Trademark Collateral, including the items set forth on Schedule 1 attached hereto.

SECTION 3. Governing Law. This Trademark Security Release shall be construed in accordance with and governed by the law of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
