U.S. INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT  
(German Grantor)

U.S. INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (German Grantor), dated December 17, 2010 ("IP Security Release"), by UBS AG, STAMFORD BRANCH., a United States branch of a Swiss bank located at 677 Washington Boulevard, Stamford, CT 06901, USA, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Assignor"), in favor of NOVELIS DEUTSCHLAND GMBH, a limited liability company (*Gesellschaft mit beschränkter Haftung*) organized under the laws of the Federal Republic of Germany, registered with the Commercial Register of the local court of Göttingen, Germany under HRB 772 (previously: Alcan Deutschland GmbH), having its business address at Hannoversche Strasse 1, 37075 Göttingen, Germany (in such capacity, the "Assignee").

W I T N E S S E T H:

WHEREAS, Assignee is party to a Security Agreement dated as of July 6, 2007 (the "Security Agreement") in favor of the Assignor, pursuant to which Assignee executed and delivered that certain U.S. Intellectual Property Security Agreement (German Grantors), dated as of July 6, 2007 (the "IP Security Agreement") in order to record the lien and security interest of Assignor in the IP Collateral (as defined in the IP Security Agreement) in the United States Patent and Trademark Office (the "PTO");

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the PTO on August 17, 2007 at Reel 19714 and Frame 0356;

WHEREAS, the IP Security Agreement was recorded with the Trademark Division of the PTO on August 17, 2007 at Reel 3684/Frame 0719;

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the PTO on July 4, 2008 at Reel 21194/Frame 0315;

WHEREAS, the secured obligations have been paid and performed in full and any and all other conditions for termination of the IP Security Agreement have been satisfied; and

WHEREAS, Assignor now desires to release its security interest in and to Assignee's right, title and interest in and to the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein but not otherwise defined herein that are defined in the IP Security Agreement shall have the meanings given to them in the IP Security Agreement.

SECTION 2. Release of Security Interest in IP Collateral. Assignor hereby terminates and releases in its entirety its lien on and security interest in the IP Collateral, including the items set forth on Schedule 1 attached hereto.

SECTION 3. Governing Law. This IP Security Release shall be construed in accordance with and governed by the law of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
