INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (as amended, supplemented or otherwise modified from time to time, this "IP Security Agreement") is made and effective as of December 16, 2010, by SUN WATER SYSTEMS, INC., a Texas corporation (the "Grantor"), in favor of ENHANCED CAPITAL TEXAS FUND, L.P., a Texas limited partnership, ("ECTFI") and ENHANCED CAPITAL TEXAS FUND II, LLC, a Texas limited liability company ("ECTFII"), and certain co-investors party hereto ("Co-Investors" and collectively with ECTFI and ECTFII, the "Creditors"). Capitalized terms used in this IP Security Agreement and not otherwise defined shall have the respective meanings ascribed to such terms in the Loan Documents (as hereinafter defined).

RECITALS

WHEREAS, the Creditors have concurrently herewith made or are about to make an extension of credit to Grantor under that certain Loan and Security Agreement, dated as of the date hereof (the "Loan Agreement") evidenced by certain secured term notes entered into in connection therewith (the "Notes" together with the Loan Agreement and such other agreements, instruments and documents entered into in connection therewith, each as amended, supplemented or otherwise modified from time to time, the "Loan Documents"); and

WHEREAS, the Grantor is required, as a condition to the Creditors entering into the Loan Agreement, to execute and deliver this IP Security Agreement to secure the Grantor's obligations pursuant to the Loan Documents;

NOW, THEREFORE, in consideration of the willingness of the Creditors to enter into the Loan Documents and to agree, subject to the terms and conditions set forth therein, to purchase the Notes to be issued pursuant thereto, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

1. Grant of Security Interest. To secure the Grantor's prompt, punctual and faithful payment of the Notes and of all of the Grantor's other obligations under the Loan Agreement, the Grantor hereby grants to the Creditors a continuing security interest in all of the right, title and interest of the Grantor in and to any and all of the following collateral, whether now owned or hereafter acquired, but excluding any Intellectual Property for which the granting of a security interest therein would terminate, invalidate, void, cancel or abandon such Intellectual Property (the "IP Collateral"):

(a) The U.S and foreign copyright registrations and applications for copyright registration (collectively, the "Copyrights"), set forth on Schedule A attached hereto;

(b) The U.S. and foreign patents and patent applications, including, without limitation, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same (collectively, the "Patents") set forth on Schedule B attached hereto;

(c) The U.S., state and foreign trademark and service mark registrations, trademark and service mark applications and all goodwill associated with the foregoing (collectively, the "Trademarks") set forth on Schedule C attached hereto;

(d) The domain names and registrations attached hereto and all goodwill associated with the foregoing (collectively, the "Domain Names") set forth on Schedule D;

(e) Any and all claims and causes of action for past, present or future infringement of any of the IP Collateral, with the right, but not the obligation, to sue for and collect damages for infringement of the IP Collateral;

(f) Any and all licenses or rights granted under any of the IP Collateral, and all license fees and royalties arising from such licenses or rights, in each case to the extent permitted by such licenses or rights;

(g) Any and all amendments, renewals, extensions, reissuances and replacements of any of the IP Collateral; and

(h) Any and all products and proceeds of any of the foregoing.

2. Requested Recordation. The Grantor authorizes and requests that the Register of Copyrights and the Commissioner of Patents and Trademarks (and any state, foreign or other authority to which this IP Security Agreement is submitted) file and record this IP Security Agreement (and any corresponding or separate forms of such jurisdiction) in order to publicly reflect the interests of the Creditors in the IP Collateral.

3. Power of Attorney. Upon the occurrence and during the continuance of an Event of Default, the Grantor hereby grants to the Creditors a power of attorney, to act as such Grantor's attorney-in-fact, with full authority in the name, place and stead of the Grantor, from time to time in the Creditors' discretion, to take any action and to execute any instrument that the Creditors may reasonably deem necessary or advisable to accomplish the purposes of this IP Security Agreement. This authority includes, without limitation, the following:

(a) To modify or amend (in the sole discretion of the Creditors and without first obtaining such Grantor's approval thereof or signature thereto) Schedule A, Schedule B, Schedule C, and/or Schedule D hereof, as appropriate, to include references to any registered intellectual property (or application or license therefor) acquired by the Grantor after the execution hereof or to delete any reference to any IP Collateral in which the Grantor no longer has or claims any right, title or interest;

(b) To execute, file and pursue (in the sole discretion of the Creditors and without first obtaining the Grantor's approval thereof or signature thereto, unless otherwise prohibited by applicable law) any application, form or other document in order to perfect, maintain, continue or otherwise protect the Creditors' interest or the Grantor's rights in the IP Collateral, including, without limitation, executing and filing (i) any financing statement, any continuation statement or any amendment thereto, and (ii) any document in any proceeding before the United States Patent and Trademark Office, the United States Copyright Office or the relevant office of any state or foreign jurisdiction (including, without limitation, the filing of applications for renewal, affidavits of use, affidavits of incontestability and opposition, interference and cancellation proceedings) and to pay any fees and taxes in connection therewith or otherwise;

(c) To execute any document required to acknowledge, register or perfect the interest of the Creditors in any part of the IP Collateral without the signature of such Grantor unless prohibited by applicable law; and

(d) To (i) endorse the Grantor's name on all applications, documents, papers and instruments necessary or desirable for the Creditors in the use of the IP Collateral, (ii) take any other actions with respect to the IP Collateral as Creditors deem to be in the best interest of Creditors, (iii) grant or issue any exclusive or non-exclusive license under the IP Collateral to anyone or (iv) assign, pledge, convey or otherwise transfer title in or dispose of the IP Collateral to anyone.

The foregoing power of attorney is coupled with an interest and is irrevocable until the Obligations (other than indemnity obligations under the Loan Documents that are not then due and payable or for which any events or claims that would give rise thereto are not then pending) secured hereby have been unconditionally paid in full.

4. Release. Unless otherwise agreed in writing by the parties, the security interests granted herein will terminate (and all rights to the IP Collateral will revert to the Grantor) upon payment and performance in full of all the Obligations (other than indemnity obligations under the Loan Documents that are not then due and payable or for which any events or claims that would give rise thereto are not then pending) secured hereby. Upon any such termination, the Creditors (at the Grantor's request and sole expense) will promptly execute and deliver to the Grantor (without any representation, warranty or recourse of any kind whatsoever) such documents as the Grantor may reasonably request and as are provided to the Creditors to evidence such termination.

5. Newly Registered Copyrights, Patents and Trademarks.

(a) Together with the delivery of the officer's certificate pursuant to Section 4.2(c)(v) of the Loan Agreement, Grantor shall notify Creditors of each application to register any Copyright, Patent or Trademark of Grantor filed by Grantor with the Register of Copyrights, the Commissioner of Patents and Trademarks or foreign or state equivalent, as applicable, after the date of this IP Security Agreement that Grantor has not already disclosed to Creditor in connection with a previously delivered officer's certificate.

(b) Grantor shall not register any maskworks, software, computer programs or other works of authorship subject to United States copyright protection with the United States Copyright Office without first complying with the following: (i) providing Creditors with at least 15 days prior written notice thereof, (ii) providing Creditors with a copy of the application for any such registration and (iii) executing and filing such other instruments, and taking such further actions as Creditors may reasonably request from time to time to perfect or continue the perfection of Creditors' interest in the Collateral, including without limitation the filing with the United States Copyright Office, simultaneously with the filing by Grantor of the application for any such registration, of a copy of this Agreement or a Supplement hereto in form acceptable to Creditors identifying the maskworks, software, computer programs or other works of authorship

being registered and confirming the grant of a security interest therein in favor of Creditors.

6. Miscellaneous.

(a) This IP Security Agreement has been entered into in conjunction with the provisions of and the security interest granted to the Creditors under the Loan Agreement. The rights and remedies of the Grantor and the Creditors with respect to the security interests granted herein are in addition and without prejudice to those set forth in the Loan Agreement, all terms and provisions of which are hereby incorporated herein by reference. In the event that any provisions of this IP Security Agreement are deemed to conflict with the Loan Agreement or the other Loan Documents, the provisions of the Loan Agreement or the other Loan Documents shall govern.

(b) This IP Security Agreement may be executed in any number of counterparts with the same effect as if all the signatures on such counterparts appeared on one document. Each such counterpart will be deemed to be an original, but all counterparts together will constitute one and the same instrument.

(c) This IP Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York without giving effect to its choice of law provisions.
