RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS ("Release and Termination") is executed as of December 16, 2010, by CIT Healthcare LLC, as agent (the "Secured Party"), with reference hereby made to that certain Trademark Security Agreement dated as of September 26, 2008 (the "Trademark Security Agreement"), between Tecomet Inc., a Massachusetts corporation and successor by merger with CHT Acquisition Sub Corp., and CHT Acquisition Corp. ("Debtor") and the Secured Party.

WHEREAS, the Debtor has requested that the Secured Party release the liens and security interests granted to it in the right, title and interest in and to the trademarks and trademark applications of the Debtor, together with the goodwill of the business symbolized thereby, set forth on Schedule I attached hereto (the "Trademarks"), pursuant to the Trademark Security Agreement.

The Secured Party does hereby certify that the security interests it holds in the right, title and interest to the Trademarks, pursuant to the Trademark Security Agreement which was recorded with the United States Patent and Trademark Office on September 30, 2008 at Reel: 003862, Frame: 0136, are released and terminated and all interests in such property previously assigned to the Secured Party under the Trademark Security Agreement are hereby reassigned to the Debtor, without recourse or representation or warranty, express or implied, of any kind.

This Release and Termination shall be governed by the laws of the Commonwealth of Massachusetts and shall relate solely to the Trademark Security Agreement.

The Secured Party authorizes and requests that the Commissioner for Trademarks and any other applicable United States government officer record this Release and Termination.
