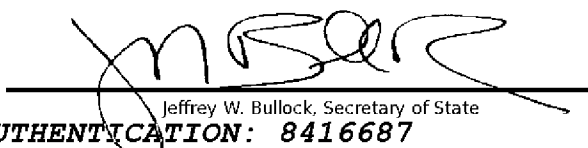

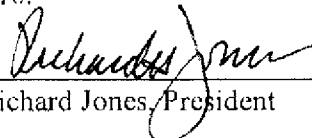

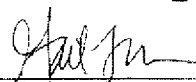
RESOLVED: That Article I of the Certification of Incorporation of the Corporation be deleted in its entirety and replaced with the following:
