**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is given as of December 29, 2010, to Harmar Mobility, LLC (the “**Grantor**”) by Union Bank, N.A., formerly known as Union Bank of California, N.A., as secured party (the “**Secured Party**”) under that certain Security Agreement dated as of March 31, 2008 (as amended, restated, supplemented or otherwise modified from time to time, being the “**Security Agreement**”) by the Grantor in favor of the Secured Party.

WHEREAS, the Grantor entered the Security Agreement was recorded in the United States Patent and Trademark Office on May 19, 2008 at Reel 3779, Frame 0759, pursuant to which the Grantor granted to the Secured Party a security interest and mortgage to all of the Grantor’s right, title and interest in and to the Trademarks identified in Exhibit A to this Release; and,

WHEREAS, in connection with the refinancing of the obligations due and owing to the Secured Party and the execution and delivery of that certain Credit Agreement dated as of even date herewith by and among the Grantor, certain of the affiliates of the Grantor and U.S. Bank, National Association, the Secured Party desires to release its security interests in and liens upon the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Secured Party hereby releases its lien on and security interest in all of the Grantor’s right, title and interest in and to the Trademarks and reassigns any and all interest it may have in such Trademarks to the Grantor.
