**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY RIGHTS**

TERMINATION AND RELEASE dated as of January 5, 2011, from Enhanced Capital New York Fund II, LLC, a Delaware limited liability company (the "Secured Party"), to Word World, LLC, a New York limited liability company (the "Company").

WITNESSETH:

WHEREAS, pursuant to the Loan and Security Agreement by and between the Company and Secured Parties dated March 25, 2008, in favor of the Secured Party (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Company to the Secured Party in certain Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on May 1, 2008 at Reel 020885 and Frame 0398;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 1, 2008 at Reel 3781 and Frame 0873;

WHEREAS, the Security Agreement was recorded with the Register of Copyrights Library of Congress on May 6, 2008;

WHEREAS, the Secured Party now desires to terminate and release the entirety of its Security Interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby agrees and acknowledges as follows:

1. Definitions. The term "Intellectual Property" as used herein, shall mean all of the Company's right, title and interest of every kind and nature as of the date hereof in the Intellectual Property (as same are defined in the Security Agreement), including but not limited to all other items listed on Exhibit A, Exhibit B and Exhibit C hereto.

2. Release of Security Interest. The Secured Party hereby terminates, releases and discharges its Security Interest in the Intellectual Property, and assigns to the Company all of the Secured Party's right, title and interest in the Intellectual Property, and any right, title or interest of the Secured Party in such Intellectual Property shall hereby cease and be void.


3. Further Assurances. Upon request by the Company, the Secured Party hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts

as may be reasonably necessary to effect the termination and release of the Security Interest contemplated hereby.
