WHEREAS, the Assignor has agreed to assign to the Assignee, to the extent that the Assignor has any interest therein, its security interest and all of its right, title and interest in each of the Marks, Patents and Copyrights as herein provided; and

- 3. <u>Acknowledgment and Acceptance</u>. The Assignee hereby acknowledges and accepts the foregoing release and assignment by the Assignor.
- 4. <u>Counterparts</u>. This Assignment may be executed in several counterparts, each of which shall be deemed an original, and all such counterparts shall constitute one and the same instrument.
- 5. <u>Binding Nature</u>. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their successors and assigns.


