## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “Release”) is made as of January 6, 2011 (“Effective Date”) by Wells Fargo Capital Finance, Inc. (formerly known as Wells Fargo Foothill, Inc.), a California corporation, in its capacity as agent for the below defined Lender Group (in such capacity, “Grantee”), in favor of the grantors listed on Schedule 1 hereto (each a “Grantor” and collectively, “Grantors”).

WHEREAS, reference is made to that certain Credit Agreement, dated as of June 23, 2006 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”) by and among Pre-Paid Legal Services, Inc., an Oklahoma corporation, on the one hand, and the lenders party thereto and Grantee (collectively, the “Lender Group”) on the other;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of June 23, 2006 (as amended, restated, supplemented, or otherwise modified from time to time, the “Trademark Security Agreement”), by and among Grantors and Grantee, each Grantor granted to Grantee a security interest in all of such Grantor’s right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 27, 2006 at Reel 3339, Frame 0882; and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 2 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.


