RELEASE OF TRADEMARK GRANT OF SECURITY

This RELEASE OF TRADEMARK GRANT OF SECURITY (this "Release"), is made effective as of December 31, 2010 by and from PNC BANK, NATIONAL ASSOCIATION, as agent, (the "Secured Party"), in favor of SOUTHEASTERN METAL PRODUCTS, INC., a North Carolina corporation whose address is 4404A Chesapeake Drive, Charlotte, North Carolina, 28216 (the "Borrower").

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Security Agreement.



For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby assigns to and releases the Borrower from the security interest in and continuing lien on all of the Borrower's right, title and interest in, to and under the Trademarks, including without limitation, such Trademarks set forth on Schedule A hereto.

SECTION 3. Release of the Security Agreement. This Release has been executed and delivered by the Secured Party for the purpose of releasing the security interest of the Secured Party in the Trademarks in the United States Patent and Trademark Office and worldwide.
