#### RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of DECENSEX 1, 2010 ("Release Date") in favor of ESCORT INC. and BELTRONICS USA INC. (together, the "Pledgors") by AMERICAN CAPITAL, LTD. (as successor by merger to AMERICAN CAPITAL FINANCIAL SERVICES, INC.), in its capacity as administrative agent (in such capacity, the "Administrative Agent").

WHEREAS, the Pledgors are party to that certain Second Lien Security Agreement, dated as of November 18, 2005 (the "Security Agreement") in favor of Canadian Imperial Bank of Commerce, acting through its New York agency ("CIBC");

WHEREAS, pursuant to the Security Agreement, the Pledgors granted to CIBC for the benefit of the Secured Parties (as defined in the Security Agreement) a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property and, in connection therewith, entered into that certain Second Lien Trademark Security Agreement, dated as of November 18, 2005 (the "Trademark Security Agreement") for the purpose of recording such security interest with respect to the trademark registrations and applications of the Pledgors, including those items set forth on Schedule A hereto (the "Pledged Collateral") with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 29, 2005 at Reel 3200, Frame 0530;

WHEREAS, pursuant to that certain Patent and Trademark Security Assignment and Assumption Agreement, dated as of July 30, 2009 (the "Assignment Agreement"), between CIBC and the Administrative Agent, CIBC assigned to the Administrative Agent the interest in and to CIBC's rights and obligations under the Trademark Security Agreement;

WHEREAS, the Assignment Agreement was recorded with the United States Patent and Trademark Office on August 5, 2009, at Reel 4038, Frame 0460; and

WHEREAS, the Pledgors have paid all of their outstanding indebtedness to the Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Parties, hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests and liens it has against the Pledged Collateral, and (iii) re-assigns to the Pledgors any right, title and interest it may have in, to and under the Pledged Collateral to the Pledgors.

The Administrative Agent shall, at the Pledgors' expense, take all further actions, and provide to the Pledgors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors to more fully and effectively effectuate the purposes of this Release.
