Releasor hereby assigns unto Releasee its entire right, title and interest in and to the Trademarks.

Releasor will execute such Uniform Commercial Code termination statements as Releasee may reasonably request in order to terminate any security interest Releasor may have in and to the Trademarks and to execute such other documents and instruments, and take other such actions (at the expense of Releasee) as Releasee may reasonably request to evidence this termination and release and the release of any security interests in the Trademarks.




