Assignor further covenants that it will at any time, upon reasonable request, execute and deliver any further assignments or other documents to carry out the purposes of this Agreement, without further consideration or fees being paid by ASSIGNEE to ASSIGNOR; provided, however, that ASSIGNOR shall not be required to incur any costs or expenses, including, without limitation, any filing or registration fees, in connection therewith.
