same would have been held and enjoyed by Assignor if this transfer to Assignee had not been made;

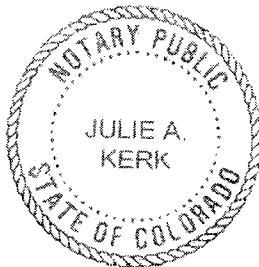
