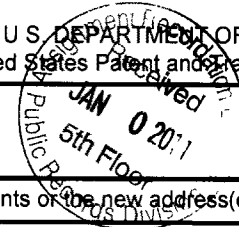

NOTICE OF SECURITY INTEREST
