

ASSIGNMENT

WHEREAS, Trudeau Foods, LLC, a Delaware limited liability company (hereinafter referred to as "Trudeau") is the sole owner of the marks listed on the attached Exhibit A ("the Trademarks");

Trudeau further agrees that it will not contest Second Bite's ownership of the marks, registrations, applications for registration, goodwill or copyrights assigned, including in any claim, action, arbitration, suit, inquiry or proceeding.

Trudeau further agrees that it will take such further actions, make all rightful oaths and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to the Trademarks, registrations, applications for registration, goodwill or copyrights in

Second Bite or its successors, legal representatives, and assigns in the U.S without additional consideration, but at the expense of Second Bite.

The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration of said marks shown in Exhibit A to said Second Bite Foods, Inc.
