**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of December 17, 2010 ("Release Date") in favor of ESCORT INC. ("Debtor") by THE HUNTINGTON NATIONAL BANK ("Bank"), as administrative agent (in such capacity, the "Administrative Agent").

**WHEREAS**, pursuant to that certain Supplemental Security Agreement Patents and Trademarks (Supplementing Security Agreement dated February 25, 2003), dated as of July 24, 2003 (the "Trademark Security Agreement"), Debtor granted to the Administrative Agent for the ratable benefit of the Lenders, parties to that certain Amended and Restated Credit Agreement, dated as of July 24, 2003, between Beltronics USA Inc. , Debtor, Bank and such Lenders, a security interest in certain intellectual property of Debtor and recorded such security interest including with respect to the trademark registrations and applications set forth on Schedule A hereto (the "Trademark Collateral") with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 7, 2003, at Reel 2700, Frame 0385; and

**WHEREAS**, in connection with a refinancing of certain indebtedness of Debtor, the Administrative Agent has agreed to release its security interest granted in the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Lenders, hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (iii) re-assigns to Debtor any right, title and interest it may have in, to and under the Trademark Collateral to Debtor.

The Administrative Agent shall, at Debtor's expense, take all further actions, and provide to Debtor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Debtor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
