

If for any reason this document fails to bring into effect the above described sale, assignment, and transfer, the TRADEMARK LICENSE AGREEMENT between the ASSIGNOR and the ASSIGNEE effective on this date shall be controlling of the rights between ASSIGNOR and ASSIGNEE regarding the mark.
