RELEASE OF SECURITY INTEREST


WHEREAS by that agreement dated April 17, 2001, originally recorded in the Trademark Assignment database of the United States Patent and Trademark Office ("PTO") on June 1, 2001 at Reel/Frame 2311/0212 (the "Trademark Security Agreement"), Computer Systems Company, Inc., 17999 Foltz Pkwy., Strongsville, Ohio 44149 ("CSC") granted to The Huntington National Bank, 917 Euclid Ave. St., Cleveland, Ohio 44145 ("Huntington") a security interest in U.S. Trademark Registration No. 1,994,581 for the trademark PAPERS, filed on December 19, 2004, and registered on August 20, 1996 (the "581 Registration").

WHEREAS, on September 7, 2010, the United States Bankruptcy Court for the Northern District of Ohio, Eastern Division, Case No. 09-20802, authorized the sale of the 581 Registration, among other assets, free of all liens, claims, and encumbrances, from CSC to Hyland Software, Inc.

WHEREAS, Huntington wishes to provide a document suitable for recording in the Trademark Assignment Database of the PTO for purposes of recording the release, relinquishment and discharge of its security interest in the 581 Registration;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Huntington hereby relinquishes, releases and discharges the security interest in the 581 Registration granted in the Trademark Security Agreement and does hereby authorize and direct the Trademark Security Agreement to be discharged of record.
