RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE is given as of this 13th day of January, 2011 by M&I Marshall & Ilsley Bank, ("Assignor"), in favor of Consolidated Commercial Controls, Inc., a Delaware corporation ("Assignee"), as follows:

WHEREAS, Assignee entered into a Security Agreement with Assignor dated as of April 28, 2006, as subsequently amended from time to time, and in conjunction therewith, Assignee entered into a Confirmatory Grant of Security Interest in United States Trademark dated as of October 31, 2007 and a Confirmatory Grant of Security Interest in United States Trademark dated as of July 31, 2008 with Assignor, which are recorded with the United States Patent and Trademark Office at Reel 3712/Frame 0411 and Reel 3828/Frame 0034, respectively (collectively, the "Security Agreement");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest in and lien upon the Trademarks and assigns any and all interest that it may have in or to the Trademarks to Assignee.

Any capitalized terms used but not defined herein shall have the respective meanings assigned to them in the Security Agreement.




