RELEASE OF TRADEMARKS SECURITY AGREEMENT

THIS RELEASE dated effective as of December 31, 2010 (this "Release") is made by Bank of America, N.A., acting in its capacity as administrative agent (in such capacity, the "Agent") under certain security agreements and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreements"), among Focus Products Group, LLC ("Focus") and Jerdon Products, LLC ("Jerdon" and collectively, the "Debtors") and the Agent.

W I T N E S S E T H:

WHEREAS, pursuant to the Security Agreements which were recorded in the records of the United States Patent and Trademark Office on the date and at the reel/frame indicated in the Schedule hereto, each Debtor granted to the Agent a continuing security interest in all of such Debtor's right, title and interest throughout the world, whether then owned or thereafter acquired in trademarks, including those set forth on the attached schedule (the "Trademark Collateral");

WHEREAS, the Agent wishes to: (a) terminate the Security Agreements against the Trademark Collateral of Jerdon and release all of its security interests covering the Trademark Collateral of Jerdon (the "Jerdon Released Collateral"); (b) release all of its security interests covering the Trademark Collateral of Focus set forth on the Schedule attached hereto (the "Focus Released Collateral") and together with the Jerdon Released Collateral, the "Released Collateral"; (c) restore all right, title and interest in and to the Released Collateral to applicable Debtor; and (d) to dissolve any and all liens and encumbrances respecting the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release its security interests in the Released Collateral, and

discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all rights, title and interest it has in and the security interests granted to Agent in the Released Collateral including those listed in the attached schedule.
