## Assignment Agreement

**THIS ASSIGNMENT AGREEMENT** ("Agreement") is made as of the Effective Date (as defined below) between

- (1) **Pybas Vegetable Seed Co., Inc.**, a company duly organized and existing under the laws of the United States of America, having its registered office located at 2330 A Street, Unit B, 93455 Santa Maria, United States of America (hereinafter "Assignor"), and
- (2) **Syngenta Crop Protection AG**, a company duly organized and existing under the laws of Switzerland, having its registered offices at Schwarzwaldallee 215, 4058 Basel, Switzerland, (hereinafter "Assignee").

### WHEREAS:

Assignee has received the beneficial ownership of certain IP Rights as per 1<sup>st</sup> January 2010 through a separate agreement and Assignor is herewith assigning legal title to these IP Rights to Assignee with an assignment effective date as of January 1<sup>st</sup>, 2010 ("Effective Date").

**NOW IT IS AGREED** as follows:

### 1. DEFINITIONS

In this Agreement unless the context otherwise requires:

"IP Rights" means all of the Assignor's utility and plant patents, plant variety protection rights, applications thereof and rights to file applications thereof (including all divisional applications, continuations and continuations in part) and other rights and interests (including through contracts with third parties), inventions, proprietary information, research and development results, technologies, scientific, technical, engineering data and literature, formulae and all other know-how in and to flowers, plants, lines and varieties, as well as in and to non-crop specific technologies of any sort, as further specified in Annex 1 to this Agreement.

### 2. ASSIGNMENT

The Assignor **HEREBY ASSIGNS** to the Assignee, and free from all liens, charges, security, licenses and other encumbrances whatsoever, title to the IP Rights, including all rights, powers, liberties, immunities and advantages attaching to them.

**3. FURTHER ASSURANCE**

The Assignor HEREBY COVENANTS to the Assignee that the Assignor will:

- 3.1 execute any document or do any act or thing which may be reasonably necessary under the law of any country for completing the transfer to the Assignee of legal title to the IP Rights assigned by Clause 2 above, including without limitation entering into any confirmatory documentation as the Assignee may reasonable require to promptly register the rights assigned herein on all the appropriate registers or otherwise enjoy the full benefit of the property and rights hereby assigned;
- 3.2 at the request of the Assignee, at its own expense, send to the Assignee by courier, as soon as reasonably practicable, a complete copy of the Assignor's prosecution file for each of the IP Rights;
- 3.3 instruct its agents, as of the Effective Date, to direct all correspondence regarding the IP Rights to the Assignee.

**4. GOVERNING LAW**

This Agreement shall be governed by and construed in accordance with the laws of Switzerland, without giving effect to the conflict of laws provisions thereof. The parties hereby submit to the exclusive jurisdiction of the competent Courts of the city of Basel.

IN WITNESS WHEREOF, the Parties have executed this Assignment in duplicate originals by their duly authorized representatives.


