## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (this "Release"), dated this 11<sup>th</sup> day of January, 2011, is by PNC Bank, National Association ("PNC").

A. WHEREAS, FinishMaster, Inc., an Indiana corporation ("FinishMaster"), granted PNC a security interest in its trademarks listed on Schedule A (collectively the "Trademarks");

B. WHEREAS PNC also recorded its interest in the Trademarks with the United States Patent and Trademark Office (the "USPTO") on May 1, 2001 as Reel/Frame 2288/0339; and

C. WHEREAS FinishMaster requests PNC to release any and all right, title, and interest in and to the Trademarks and PNC agrees to release any and all such right, title, and interest.

NOW, THEREFORE, FOR VALUE RECEIVED, PNC agrees as follows:

1) PNC does hereby terminate and release its security interest in and to the Trademarks and all rights therein of any type or description.

2) PNC hereby authorizes FinishMaster (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish PNC's rights and interest in the Trademarks.


3). This Release is governed by the law of the State of Indiana, excluding its choice of law principles to the contrary.

4) This Release shall be binding upon PNC and its successors and assigns and inures to the benefit of FinishMaster and its successors and assigns.

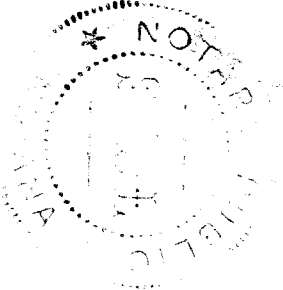
