

representatives, together with all of the income, royalties, damages and payments now or hereafter due or payable with respect thereto.

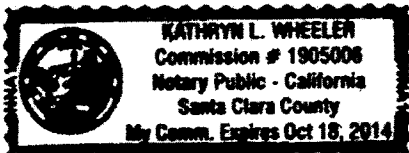

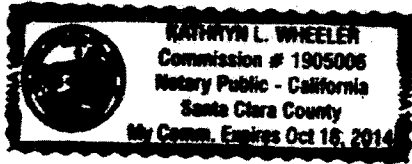
