ASSIGNMENT

THIS ASSIGNMENT is made effective, *nunc pro tunc*, as of June 17, 2010, between Denali Software, Inc., a California corporation ("Assignor"), and NVELO, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor, a corporation organized and existing under the laws of the state of California, having a place of business at 2655 Seely Avenue, Building 5, San Jose, California 95134 has adopted, used, is using and or intends to use and has applied to register the mark FLASHPOINT, U.S. Trademark Serial No. 77/860,979 filed on October 29, 2009, as identified in the attached Schedule at Exhibit A (herein referred to as the "MARK").

WHEREAS, Assignor did transfer assets including all of its right, title and interest in the subject MARK to Assignee effective June 17, 2010, by unrecorded agreement between the parties, and the parties desire to record this Confirmatory Nunc Pro Tunc Trademark Assignment Agreement in the Records of the PTO against the MARK identified at Exhibit A;

WHEREAS, Assignee, a corporation organized and existing under the laws of the state of Delaware, having a place of business at 5201 Great America Pkwy, Suite 49, Santa Clara, CA 95054, desires to acquire the MARK together with the good will of the business; and

WHEREAS, the undersigned signatory of Assignor became Vice President of Assignor on or around June 17, 2010, and has continuing authority to execute this Confirmatory Nunc Pro Tunc Trademark Assignment on behalf of Assignor.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Assignor does hereby sell, assign, and transfer unto Assignee, its successors and assigns effective *nunc pro tunc* as of June 17, 2010, all of its right, title and interest in and to the MARK together with the good will of the business symbolized by the MARK, including any registrations that may have issued or applications that are pending in Assignor's name for the MARK. Assignor further sells, assigns and transfers unto Assignee its

entire right, title and interest in and to any and all causes of action and rights of recovery for past infringement of the MARK.


ASSIGNOR agrees that it will, at the expense of the ASSIGNEE, execute, deliver and acknowledge all such further instruments of conveyance as ASSIGNEE may reasonably require if necessary to accomplish the assignment, transfer, and recordation thereof of said MARK.

This assignment shall be binding upon the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee.
