## ASSIGNMENT OF TRADEMARK

3. The Assignor hereby warrants and represents that it has not entered and will not enter into any assignment, contract, understanding, or activity in conflict herewith.
4. The term and covenants of this agreement shall inure to the benefit of the Assignee, its successors, assigns and other legal representatives, and shall be binding upon the Assignor, his respective heirs, legal representatives and assigns.


