## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is made and entered into as of this 20<sup>th</sup> day of

JANUARY, 2011, between James Lewis, an individual residing in the county of CHESTER with the mailing address of P.O. Box 275, Uwchlan, Pennsylvania, 19480,

("Transferor"), and WALL DOCTORX, LLC, a limited liability company organized under the laws of Delaware located and doing business at P.O. Box 275, Uwchlan, Pennsylvania, 19480, ("Transferee").

WHEREAS on September 22, 2009, Transferor filed application Serial No. 77/581,833 to register his trademark WALL RX™ (the "Trademark") on "Intent to Use" basis; AND

WHEREAS in August, 2009, Transferor formed Transferee, a limited liability company organized under the laws of Delaware, for the purpose, inter alia, of developing, carrying out and conducting the business relating to the goods on which Transferor intends to use the Trademark; AND

WHEREAS Transferor is the sole member and owner of Transferee,

### AGREEMENT

NOW THEREFORE, in consideration of the mutual promises and covenants made herein and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:


- (A) Transferor hereby assigns, transfers and conveys to Transferee all right, title and interest in and to U.S. Trademark Registration Application Serial No. 77/581,833 entitled WALL RX™, including without limitation all common law trademark rights, together with all goodwill of the business symbolized by and associated with the Trademark.
- (B) Transferee hereby assumes all liabilities and obligations, and acknowledges existing encumbrances, if applicable, existing or arising in connection with the assignment described in Paragraph (A) hereof, except as otherwise agreed in writing by the parties.

(C) Without limiting the foregoing provisions, Transferor agrees to take whatever further action is deemed necessary or appropriate by Transferee to properly and completely effect the transfer to Transferee of the Trademark and to establish full custody and ownership of such Trademark by Transferee.


(D) This Trademark Assignment Agreement shall be governed by the internal laws of the State of Pennsylvania, without reference to its conflict of laws principles.


