**ARTICLES OF AMENDMENT
OF
VESTURE ACQUISITION CORP.**

Pursuant to Section 55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

I.

The name of the corporation is Vesture Acquisition Corp.

II.

The text of the amendment adopted is as follows:

The Articles of Incorporation of this corporation shall be amended by deleting Article I in its entirety and inserting therefor a new Article I to read as follows:

“The name of the corporation is Vesture Corporation.”

III.
