WHEREAS, Grantor is the owner of the Property identified in Exhibit 1 hereto (hereinafter collectively referred to as the "Property");

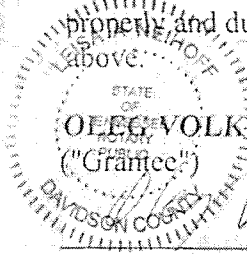
