Pursuant to Section 14-11-904 of the Georgia Limited Liability Company Act, and Section 14-2-1105(b) of the Georgia Business Corporation Code, the undersigned limited liability company as the surviving limited liability company delivers to the Secretary of State these Articles of Merger and Certificate of Merger and sets forth the following information:

1. The name and jurisdiction of organization or formation of each constituent business entity that is merging (including the state of incorporation of the corporation that is merging) is:

- (a) The Weather Channel, Inc., a Georgia corporation
- (b) The Weather Channel Interactive, LLC, a Georgia limited liability company

2. The name of the surviving limited liability company into which the corporation that is the other constituent business entity is merging is The Weather Channel Interactive, LLC. The Weather Channel Interactive, LLC is a Georgia limited liability company resulting from the conversion of The Weather Channel Interactive, Inc., a Georgia corporation, pursuant to O.C.G.A. §14-2-1109.1.

4. The effective date and time of the merger shall be 11:59 p.m., Eastern Time, on December 31, 2010.

5. The executed Agreement and Plan of Merger is on file at the principal place of business of the surviving limited liability company, which is: 300 Interstate North Parkway SE, Atlanta, Georgia 30339-2403. A copy of such Agreement and Plan of Merger will be furnished by the surviving limited liability company, on request and without cost, to any shareholder or member of any constituent entity.

6. The Agreement and Plan of Merger has been duly authorized and approved by each constituent business entity in accordance with Section 14-11-903 of the Georgia Limited Liability Company Act. In connection with such authorization and approval, the Agreement and Plan of Merger was duly approved by the sole shareholder of the corporation that is a party to the merger, in accordance with Section 14-2-1109 of the Georgia Business Corporation Code.

7. The surviving limited liability company hereby undertakes to make the request for publication of a notice of filing hereof and payment therefor in accordance with Section 14-2-1105.1(b) of the Georgia Business Corporation Code.
