TRADEMARK ASSIGNMENT

The Company hereby assigns, transfers and sets over to Purchaser, its successors and assigns, and Purchaser hereby accepts, the Company's entire right, title and interest, whether statutory or at common law, in and to the Marks, together with the goodwill of the business identified through the use of and symbolized by the Marks, in the United States of America and throughout the world, including the entire right, title, and interest in and to all claims for damages by reason of past infringement of the Marks, together with the right to sue for, collect, and retain the proceeds relating to any such infringement, and in and to all legal equivalents of the Marks in foreign countries to the extent any such rights exist in foreign countries.
2. Company hereby agrees, without further consideration and without expense to the Purchaser, to sign all lawful papers and to perform all other lawful acts which the Purchaser may reasonably request to make this assignment of the Marks fully effective.
3. Except as provided for in Section 2 hereof, nothing in this Trademark Assignment shall alter any liability or obligation of the Company or the Purchaser arising under the Separate Agreement, which shall govern the representations, warranties and obligations of the parties with respect to the Marks. In the event of any conflict or ambiguity between the terms hereof and the terms of the Separate Agreement, the terms of the Separate Agreement shall govern and be controlling.

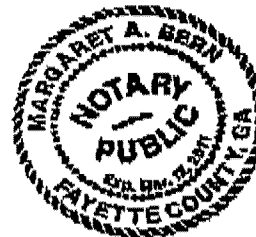

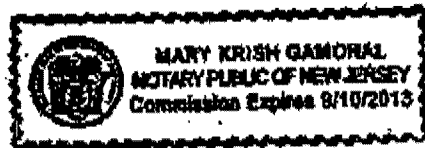
