TRADEMARK ASSIGNMENT

This Assignment is made effective this January 21, 2011, by HMS Trading, Inc., a Delaware corporation, having its sole office address at 103 Foulk Road, Wilmington, Suite 200, Wilmington, Delaware 19803, in favor of HMS Investments, Inc., a Delaware corporation, having its sole office address at 103 Foulk Road, Wilmington, Suite 200, Wilmington, Delaware 19803.

WHEREAS HMS Trading, Inc. has adopted and used, and, through a related party license agreement, continues to use the HERLEY AND DESIGN mark, which is registered with the US Patent and Trademark Office under registration number 2777402 (hereinafter referred to as the "Trademark").

WHEREAS: HMS Trading and HMS Investments, Inc. have entered into a **Plan of Merger and Complete Liquidation** pursuant to which HMS Trading will be merged with and into HMS Investments, Inc., and all of the assets and liabilities of HMS Trading, including the Trademark, shall be assigned to HMS Investments, Inc., and the separate corporate existence of HMS Trading shall cease (hereinafter, the "Merger").

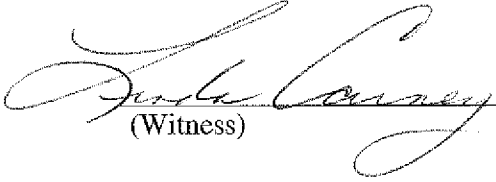
AND WHEREAS: it is desired that the assignment of said Trademark contemplated by the **Plan of Merger and Complete Liquidation** be made of record in the United States Patent and Trademark Office.

NOW, THEREFORE, pursuant to the **Plan of Merger and Complete Liquidation**, and, for good and valuable consideration, receipt of which is hereby acknowledged, HMS Trading, Inc. does hereby assign and transfer unto said HMS Investments, Inc., and for HMS Investments, Inc.'s successors and assigns, all right, title and interest in and to said Trademark, together with the goodwill of the business symbolized by said Trademark, and the registration thereof; and for aforesaid considerations HMS Trading, Inc. hereby covenants, agrees and undertakes to execute whenever requested by HMS Investments, Inc., all applications, assignments, lawful oaths and any other documents that HMS Investments, Inc. may reasonably deem necessary or desirable for securing to HMS Investments, Inc., or for maintaining for HMS Investments, Inc., the Trademark hereby assigned or agreed to be assigned; all without further compensation to HMS Trading, Inc.

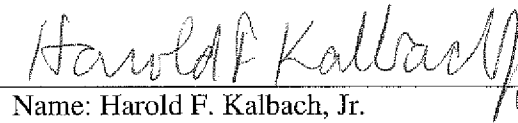

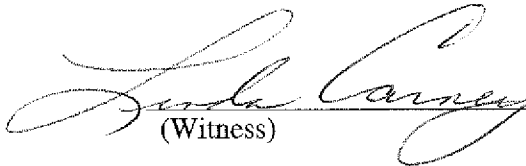
