## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made this date between OrthoRx, Inc., a Delaware corporation, whose address is 2601 Pinewood Drive, Grand Prairie, Texas 75051 ("Assignor"), and Ancillary Advantage, Inc., a Delaware corporation, whose address is 3010 Gaylord Parkway, Suite 240, Frisco, Texas 75034 ("Assignee").

2. Further Actions. From time to time, if, as and when requested by Assignee, or by its successors or assigns, Assignor, or its successor or assigns, shall execute and deliver or cause to be executed and delivered all such instruments, authorizations, and other documents, and shall take or cause to be taken all such further or other actions, as the Assignee or its successors and assigns may deem necessary or appropriate in order to vest in and confirm unto Assignee all rights, titles and interests Assignor possesses in and to the Mark and other items referenced in Section 1 of this Agreement and otherwise to carry out the intent and purposes of this Assignment.
