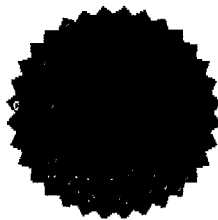

OSI Acquisition Sub, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on the 19th day of February, 2004, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the stock of MAXXAR Corporation, a corporation originally incorporated on the 17th day of October, 1994 under the name Vysion Acquisition Corporation, pursuant to the Business Corporation Act of Michigan.
