## RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST ("Release") is made and effective on December 22, 2010 by RBS Citizens, National Association, a national banking association ("Assignee").

**WHEREAS**, Advantage Refrigeration, LLC, an Illinois limited liability company ("Assignor") and Assignee entered into a Trademark Security Agreement dated January 31, 2008 (the "Security Agreement") pursuant to which Assignor granted a security interest in the "Trademarks" (as defined in the Security Agreement) to Assignee (the "Security Interest").

**WHEREAS**, the Security Agreement was made for collateral purposes pursuant to a Loan Agreement between Assignor and Assignee dated January 31, 2008, as such has been amended from time to time.


**WHEREAS**, the Loan Agreement has been terminated, and pursuant to Section 8 of the Security Agreement, the Assignee is required to take such actions as may be necessary or proper to terminate the Security Interest.

**NOW, THEREFORE**, for value received, Assignee hereby releases and discharges the Security Interest and relinquishes all right, title, and interest it may have in the Trademarks (as defined in the Security Agreement), including the trademark "SMART PARTS CONNECTION" (U.S. registration number 3,304,816 registered on October 2, 2007).
