**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (this "Release"), dated this 11<sup>th</sup> day of January, 2011, is by PNC Bank, National Association ("PNC").

A. WHEREAS, FinishMaster Services, Inc., an Indiana corporation ("FinishMaster Services"), granted PNC a security interest in its trademarks listed on Schedule A (collectively the "Trademarks");

2) PNC hereby authorizes FinishMaster Services (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish PNC's rights and interest in the Trademarks.


3) This Release is governed by the law of the State of Indiana, excluding its choice of law principles to the contrary.

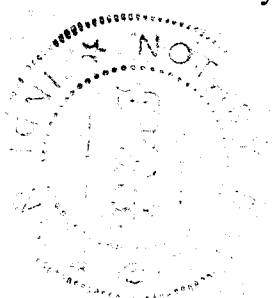
