**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Release**") is made as of January 28, 2011 ("**Effective Date**") by and between Digital Federal Credit Union, a federal credit union, with its principal office at 220 Donald Lynch Blvd., Marlborough, Massachusetts 01752 (Secured Party), and Softscape (Massachusetts), Inc., a Massachusetts corporation, and Softscape, Inc., a Delaware corporation, with its principal office at 526 Boston Post Road, Wayland, Massachusetts 01778 ("**Debtors**").

**WHEREAS**, pursuant to the terms and conditions of that certain Multi-Party Security Agreement by and between Debtors and Secured Party dated July 14, 2004 (the "**Security Agreement**"), Debtors granted to Secured Party a continuing security interest in and to all of Debtors' right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Debtors (collectively, the "**Trademarks**"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, together with the goodwill associated therewith;

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office ("**PTO**") on September 22, 2004 at Reel/Frame 3048/0905; and

**WHEREAS**, Debtors have paid all of its outstanding indebtedness to Secured Party,

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those Trademarks set forth on Schedules A, in any jurisdiction throughout the world, other than such filings made in the United States Patent and Trademark Office.


