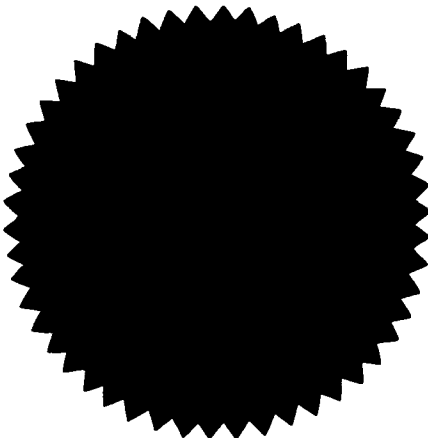

FIRST: The name and the state of organization of each of the constituent entities (the "Constituent Entities") party to the merger (the "Merger") herein are as follows:
